### JAZZFEST APPLICATION & GUIDELINES

## JAZZ PENSACOLA

**Location:** Pensacola's historic Seville Square, Alcaniz and Zaragoza streets

**Entry fee:** \$200 for all exhibitors. The fee, paid by check/money order, and the signed release form are due with the application. Your application will not be reviewed without it. Application and fee do not guarantee acceptance.

**Deadline:** May 3, 2021

**Pensacola JazzFest dates and times:**

Sat., May 15, 2021, 10 a.m. to 7 p.m.

Sun., May 16, 2021, 10 a.m. to 6 p.m.

**Setup:**

You may set up Friday, May 14, after 1 p.m. or Saturday, May 15, after 7 a.m. You must be set up by opening time, 10 a.m. Saturday, May 15.

**Breakdown:**

At the conclusion of JazzFest at 7 p.m. Sunday, May 16, you are responsible for removing all materials, tables, canopies, etc. You must leave your space cleared and clean.

**More info:**

- The fee will be returned in full if your application is not accepted. No refunds after March 31, or for weather, acts of God, civil disobedience or any circumstance Jazz Pensacola deems out of its sole care, custody or control.
- Acceptance in the show is a commitment for you to show for all hours listed above. Arts and crafts hours are different from food and entertainment hours, and you may not remain open after JazzFest performances have concluded for the day.
- Acceptance and assignment space in the show is non-transferable. Only the artist/craftsperson on the application may show in the booth space. JazzFest reserves the right to remove misrepresented or inappropriate material from the show; this includes products that are determined to compete with merchandise offered for sale in the Jazz Pensacola Merchandise Tent. No nudes, partial nudes or erotic scenes may be shown. No retail or commercial items accepted.
- Arts and crafts spaces are 10' x 10'. Indicate special needs on your application. We will TRY to accommodate requests. Please unload/load as quickly as possible. Driving vehicles in the park is greatly discouraged. Please use the street. Fountain Park parking is available for you to park, but remember it fills quickly. We also have a reserved parking lot within walking distance on Barrack Street behind The Fish House restaurant. DO NOT leave vehicles/ trailers, etc., on Zaragoza and Alcaniz streets.
- Vendors may not utilize music, loudspeaker systems, or megaphone devices.
- Shade is not guaranteed. Should it rain, no vehicles are allowed into the streets within the barricaded area of the festival site.
- JazzFest provides continuous security. However, it is the vendor's sole responsibility to provide for his own protection. JazzFest/Jazz Pensacola assumes no liability for loss, damage, or misplacement of merchandise, equipment or monies from any or all causes.
- No animals allowed, except guide dogs used by blind persons.
- Exhibitors are responsible for collecting and reporting Florida's Sales Tax.
- Any failure to follow these guidelines will result in a vendor not being accepted the following year.
